**PERMANENT PARTIAL DISABILITY SCHEDULE**

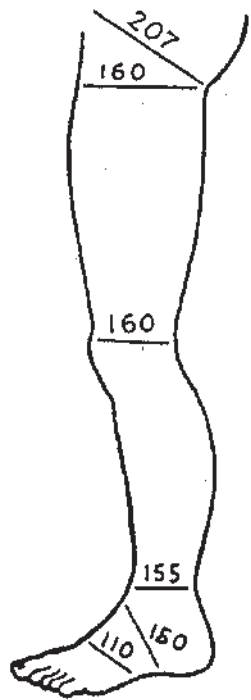

 in One Eye - 140

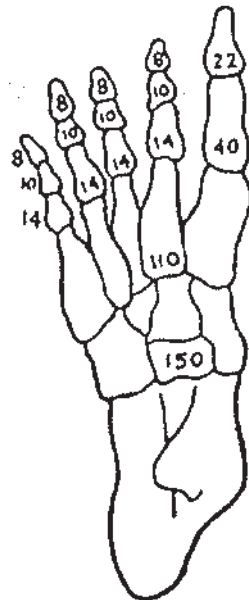

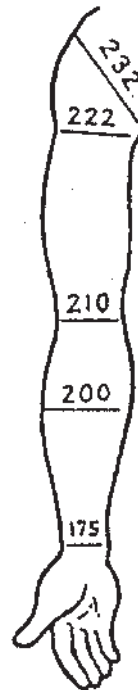

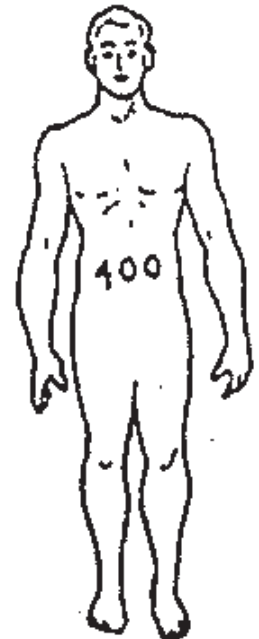
